## **Risk Statement:**

Refer to RRS 3. By participation in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include, but are not limited to: strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

## **Insurance:**

Each participating boat shall have current third-party liability insurance with a minimum of not less than \$100,000. Proof of insurance shall be presented at registration.

## **Rules:**

This regatta will be governed by the 2021 – 2024 Racing Rules of Sailing (RRS).
